2) MINUTES OF PREVIOUS MEETING

3) MATTERS ARISING

4) TREASURER'S REPORT

Balances are £9045.27 in the Charity Bank notice account and £3186.51 in the Community account. £0 in cash. Membership is stable . ~225 members currently; ~300 including household members.

5) OLD PRIORY GARDENS (OPG)

Taplow Parish Councillor, Saty Joshi, has produced a comprehensive report on OPG including current usage and recommendations for an onging strategy, project plan and actions. There appears to more of an issue with funding ongoing maintenance rather than one-off injection of funds.

Robert Miles, director from Cliveden, has been round OPG and offered a ranger for a day to assess what is actually in OPG.

Jane & Jacqueline don't think it should be fenced off.

6) PLANNING

General planning still seems rather quiet!

a) Updates

Appeals still in progress at Skyfall.

Roof lights to no 6 Ellington Gardens. Multiple objections for privacy but it is a Certificate of Lawfulness so only legal matters could be considered.

b) New applications

Concern over planning permission at Joes Folly at Amerden Lake with an application to build

16 houses on the old kennels site; they have recently applied for planning permission to drain surface water into the lake rather than a full new drainage system.

c) Local Plan

Input now submitted.

- d) Status of Ellington Road footpath no progress. Houses been told they need to cut back and clear the footpath.
- e) A developer talked to Taplow Parish Council about several fields including the car boot field station parking for 800 cars and 100+ houses.
- f) Maidenhead Rowing Club are updating their CCTV systems and re-erecting their signage. Edra has requested that they also reinstate the public footpath signage at their main entrance.
